Intangible Tax

Required on obligations to pay money involving real estate. The rate is .002 for each \$1.00 consideration. State Doc Stamps and Intangible Tax are required on any Agreement for Deed or Contract for Deed. The base is the amount of the agreement less any down payment paid. The remainder is figured just like a mortgage.
