

Establishment of Membership Account

Payment in full is due each month upon receipt of the Monthly Statement. Applicant agrees to pay all Food, Beverage and Gift Store charges in a timely manner according to the Club's policies and agrees that the Club may assess a late charge for past due accounts.

By providing Credit Card numbers below, applicant agrees that House Charges in arrears sixty (60) days or greater will be charged to one of these Credit Cards by the Palm Beach Yacht Club Accounting Department. Applicant signature(s) below provides the Club with authorization for such transactions. After a reasonable effort by the Palm Beach Yacht Club to collect unpaid bills, the balance due will be subject to the maximum interest allowed by law, legal fees and any other collection costs incurred by the club.

If in the sole judgement of the Membership Committee such member a) acts in a manner unbecoming a gentleman or lady while on club premises; b) violates any provision of these Rules and Regulations or the terms and conditions of this agreement; or c) defaults in the payment when due of membership dues or their house food and beverage account, the Club may suspend or terminate the membership of any member upon giving such Member written notice of suspension or termination addressed to said member's address as it appears in the Club's record.

Companies with corporate accounts must provide each individual Member's Business Cards and will be responsible for each individual member on the company membership account unless otherwise specified. Company employees holding a membership card without signing privileges on the company account must fill out a separate credit application if credit is desired. Written notice will be required to make any changes on corporate or individual charge accounts.
