President's Message



Mentoring

There are few areas in which the Bar was slower to meet new challenges than mentoring. And yet, there are few areas as crucial to the future of law.

We have taught law students through the case system since it was implemented by the Harvard Law School in 1870. All of us know this system works well in teaching legal theory, but poorly in passing along practical knowledge. This is a significant problem; law is not so much application of legal theory to facts as it is the application of human experience to legal problems. And despite the infinite number of problems that can present themselves to a lawyer, chances are another lawyer previously worked their way through a similar problem. Traditionally, how to deal with specific situations and the proper way to practice law was knowledge that was passed down from lawyer to lawyer. How to practice law was something taught by lawyers, not law professors, and was a responsibility relished by all lawyers.

The opportunity to sit down for a talk with more experienced lawyers, however, vanished as our practices grew more complex and our lives grew busier. Nor did it help that the Bar grew larger and the personal contacts that made it easy for us to ask for help diminished. We in the Bar were slow to recognize that responsibility for mentoring – which once consisted of unstructured teaching amongst lawyers – had been transferred to the Bar. The Bar corrected its shortsightedness and implemented mentoring programs, but now suffers from great difficulty in arranging mentor-mentee relationships. Ironically, the challenge for mentoring has now transferred back to individual lawyers.

This challenge comes with enormously high stakes. Few law schools show interest in changing their nineteenth century format to meet the needs of the twenty-first century, and it is only through mentoring that lawyers will learn how to – and how not to – practice law. It is time for all of us to pass along our experiences and become teachers again. Whether our efforts at mentoring are successful will determine how all of us practice law in the future.

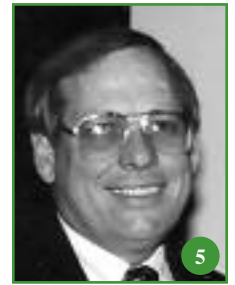
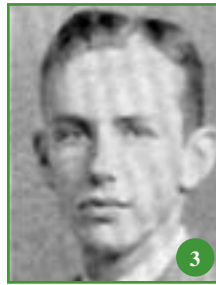
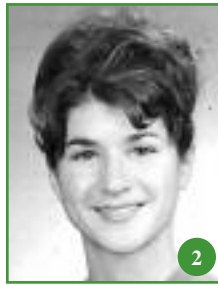

Minutes of the Young Lawyers Section February 7, 1969, Holiday Inn

Punitive Damages – Is There A Formula

The United States Supreme Court cases of BMW of North America, Inc. v. Gore, 517 U.S. 559, 575 (1996) and State Farm Mutual Automobile Ins. Co. v. Campbell, 538 U.S. 408, 418 (2003) are often cited by lawyers for the proposition that punitive damages may not exceed nine times the amount of a compensatory award. A close reading of those cases shows that is not the law. While both of those cases discuss at length a four to one ratio of punitive damages to compensatory damages as nearing the constitutional limits of due process and in Campbell, *supra*, the Court stated:

“Single-digit multipliers are more likely to comport with due process,”

Neither case sets any specific multiplier as an absolute bar to punitive damages.

The Florida Supreme Court in Engle v. Liggett Group, Inc., et al., 32 Fla. L. Weekly 1 (Jan. 5, 2007) had an opportunity to establish the outer constitutional limits of punitive damages in the State of Florida. Prior to Engle, the appellate courts of Florida had not even discussed the issue of the relationship between the amount of compensatory damages awarded and the amount of punitive damages. In Owens-Corning Fiberglass Corp. v. Ballard, 749 So. 2d 483 (Fla. 1999), a punitive damage award of \$31 million was approved where the compensatory damages were \$1.8 million. Thus, the punitive damages were 18 times the amount of the compensatory award.

The landmark case on punitive damages in Florida is Ault v. Lohr, 538 So. 2d 454 (Fla. 1989). In that case, a jury awarded zero dollars compensatory damages and \$5,000.00 in punitive damages. The Supreme Court of Florida upheld the award concluding that actual physical damage was not necessary for

a punitive award. Quoting Lassiter v. International Union of Operating Engineers, 349 So. 2d 622, 625 (Fla. 1976), the Court stated

“Nominal damages are awarded to vindicate an invasion of one’s legal rights where, although no physical or financial injury has been inflicted, *the underlying cause of action has been proved to the satisfaction of the jury. Accordingly, the establishment of liability for a breach of duty will support an otherwise valid punitive award even in the absence of financial loss for which compensatory damages would be appropriate.*” (emphasis by the Court).

In Arab Termite and Pest Control of Florida, Inc. v. Jenkins, 409 So. 2d 1039, 1043 (Fla. 1982), the Court stated that punitive damages:

“are to be measured by the enormity of the offense, entirely aside from the measure of compensation for the injured plaintiff.”

In Engle, *supra*, a \$145 billion punitive damage award was reversed for, among other reasons, its excessiveness. The Court held, for the first time that, consistent with the U.S. Supreme Court findings in Gore and Campbell, appellate review of a punitive damage award must include a determination as to whether the award of punitive damages bears a reasonable relationship to the award of compensation. The Court did not hold that either Gore or Campbell establishes a specific ratio beyond which punitive damages may not extend. A close reading of both Campbell and Gore would not justify such a holding. Both of those cases were property damage cases rather than personal injury suits. Indeed, both Campbell and Gore refer to the fact that a higher punitive damage award might well be justified depending upon the severity of the physical damage suffered by a plaintiff. Florida Courts have consistently found that the most important factor in determining the reasonableness of a punitive damage award, is the extent of outrageousness of the conduct of the Defendant. See Arab Termite, *supra*.

In Engle, the Court cites with approval in Campbell at Page 424 – 26 that:

“[W]e have consistently rejected the notion that the constitutional line is marked by a simple mathematical formula, even one that compares actual *and potential damages to the punitive award.* TXO [Production Corp. v. Alliance Resources Corp.], 509 U.S.] at 458. We decline again to impose a bright-line ratio which a punitive damage award cannot exceed.”

While Campbell goes on to state that single-digit multipliers are more likely to comport with due process (thus leading to the off cited nine to one limit), that Court also reflects that a much higher ratio may well be justified where the amount of compensatory damages are small and a lesser ratio may be all that is necessary where compensatory damages are very large. Nevertheless, Campbell concludes that there are “no rigid bench marks that a punitive damages award may not surpass.”

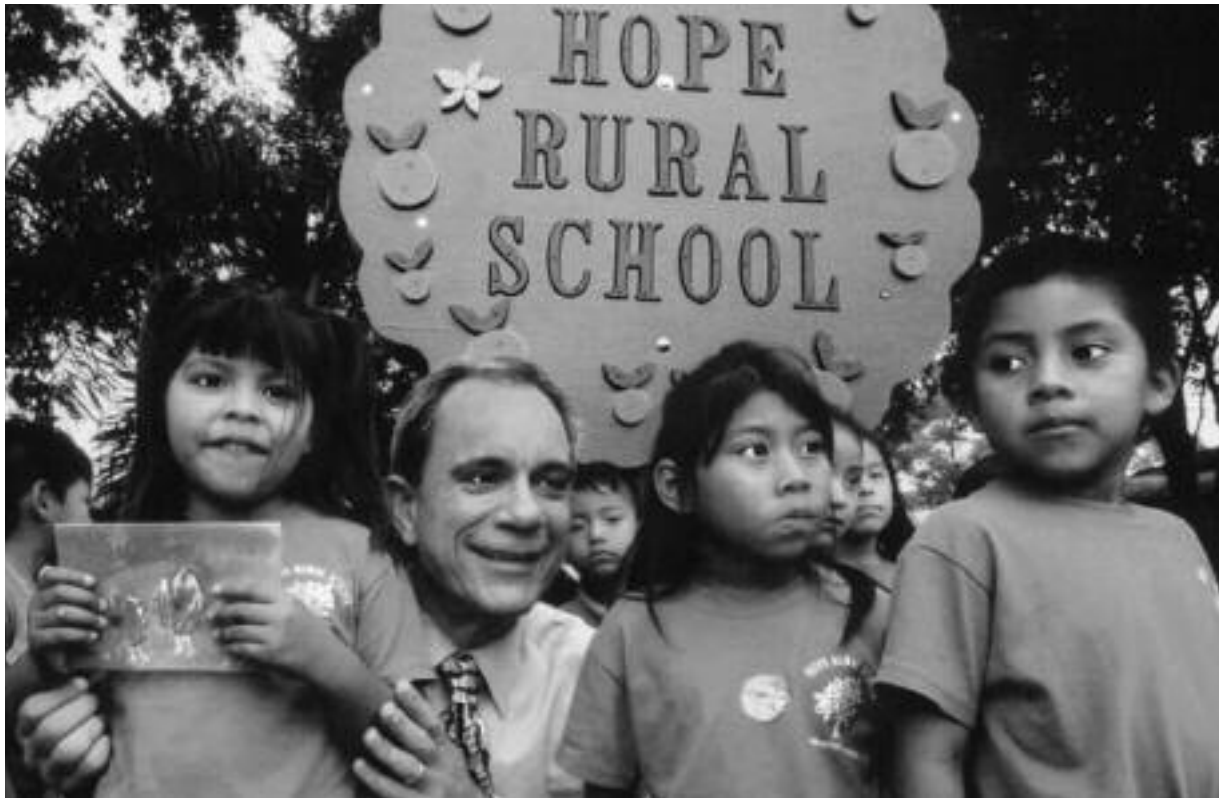
Campbell, Gore and now Engle hold that there are three determinates which must be reviewed when an award of punitive damages is alleged to be unconstitutional and excessive.

“(1) the degree of reprehensibility of the defendant’s misconduct; (2) the disparity between the actual or potential harm suffered by the plaintiff and the punitive damages award; and (3) the difference between the punitive damages awarded by the jury and the civil penalties authorized or imposed in comparable cases.”

Engle v. Liggett, *supra*, will be oft cited for many reasons. It is a landmark decision in tobacco litigation, class actions and punitive damages. On the issue of punitive damages, it holds that an arbitrary relationship between the amount of a compensatory award and the amount of punitive damages awarded does not exist.

County Court Judge Janis Brustares Keyser

“Getting people to communicate with each other and helping them resolve their disputes”

Judge Keyser fulfilled a vision of becoming a lawyer. Born and raised in Miami, the seed for Janis Brustares Keyser’s interest in becoming a lawyer was planted by her late father, a manager for Motors Insurance Corporation, who



wanted to become a lawyer himself. Her interest grew when she worked as a gofer and file clerk for an appellate law firm, while working towards her undergraduate degree at Florida State University. She initially planned a career as a college history professor, but instead decided upon a career in the law. After graduating from FSU *summa cum laude*, Janis Keyser then attended University of Florida College of Law, where she first met her husband, Gregory Keyser.

Judge Keyser’s father again helped influence her career path by suggesting she send her resume to every Federal Judge in the Southern District of Florida. She was fortunate enough to obtain a clerkship with United States District Court Judge Jose A. Gonzalez Jr., whom she fondly describes as “a brilliant jurist.” The most important lesson that Judge Keyser learned from Judge Gonzalez was that you can work hard at the practice of law and still manage to have a good time.

After her two-year clerkship with Judge Gonzalez, Judge Keyser became an associate with Jones & Foster, P.A. At Jones & Foster, P.A., Judge Keyser met and worked closely with Hayward D. Gay, whom she considers a mentor and good friend. She recalls traveling throughout the country and having substantial deposition and trial support experience as a young lawyer.

Judge Keyser then obtained a clerkship with Fourth District Court of Appeal Judge James C. Downey. During

this approximately year-long clerkship, Judge Keyser developed an interest in and appreciation for appellate law practice. She subsequently continued to develop her appellate law practice and obtained Florida Bar Board Certification in Appellate Practice, a distinction that she continues to maintain today.

After her children Mallory and Spencer were born, Judge Keyser worked part-time with Reid, Ricca & Rigell, P.A. During her five years with that firm, Judge Keyser continued her appellate and litigation support practice.

Judge Keyser ultimately went back to work with her mentor, Hayward Gay, who had by then formed the firm of Gay, Ramsey & Lewis, P.A. She continued to work with Hayward through the firm’s merger with Billing, Cochran, Heath, Lyles, Mauro & Anderson, P.A., where her husband Gregory is a partner.

After her children left home for college, her daughter Mallory to the University of Florida and her son Spencer to Florida State University, Janis Keyser

decided that she was ready for a new challenge. She completed a challenging application and interview process and, while on I-95 en route to a Uniform Motion Calendar hearing in Broward County, she received a telephone call from Governor Jeb Bush who asked her how would she like to be a judge. Judge Keyser was then appointed to fill the vacancy created by the retirement of Judge Susan Lubitz and was thrilled that her father, who had inspired her so greatly, had the opportunity to know that she had been appointed as a judge. Shortly thereafter, Judge Keyser was sworn in by Judge Gonzalez, the “brilliant jurist” who had such a great influence on her.

Since taking the bench in April 2006, Judge Keyser has done a great deal of reading and learning. Serving in the County Civil division has presented many new challenges to her, but she enjoys meeting those challenges and learning all that comes with them. She takes particular pleasure in

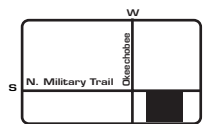

Lawyers' Ancillary Businesses

The solution to a problem changes the nature of the problem.

– "Peers's Law"ⁱ

So-called "ancillary" businesses owned by lawyers have proliferated in recent years. The dramatic increase in these activities began in the 1980s, as lawyers and law firms sought ways to enhance key practice areas, solidify important client relationships, and, of course, increase revenues – in short, to compete in a changing and increasingly global economy.

No ethical rule prohibits ancillary business. Instead, various rules impose conditions on a lawyer's involvement in ancillary business. Rule 4-5.7 of the Rules Regulating the Florida Bar, in effect since April 2002, simply states that a lawyer who is involved in providing ancillary services is subject to the Rules Regulating the Florida Bar under certain conditions. The rule does not employ the term "ancillary," rather refers to "nonlegal" services. Unlike ABA Model Rule 5.7, Florida Bar Rule 4-5.7 does not limit its application to services that are temporally or substantively related to legal services. Both rules refer to services that are "distinct" from legal services. According to the Restatement, *distinct* in this context refers to the nature of or relationship between the legal and ancillary services, the physical locations of the enterprises, and the affiliations of the personnel involved.ⁱⁱ The bottom line is ensuring that the client fully understands the roles and affiliations of those providing the legal and nonlegal services and the ramifications attendant to each relationship.

The existence of a separate ethics rule addressing ancillary services does not suspend the effect of other applicable rules that have long applied: a lawyer involved in delivering nonlegal services must avoid conflicts of interest with law clients, comply with the ethical requirements applicable to engaging in business transactions with a law client, and avoid engaging in conduct involving dishonesty, fraud, deceit, or misrepresentation. To avoid ethical and liability issues arising out of ancillary business, a lawyer or law firm should implement the following actions and policies:

1. The law practice and the ancillary business should have separate operations, personnel, accounting, billing, and physical locations (or at least entrances). Although the rule does not require this separation, it will go far to avoid confusion and its consequences.

2. The ancillary business should provide no legal services (i.e., the unlicensed practice of law).

3. There must be no sharing of fees between the law practice and the ancillary business. (An owner of the ancillary business, however, may share in the profits in the conventional manner, i.e., by dividends or partnership distributions.)

4. The law practice and the ancillary business should maintain an integrated client database and treat conflicts issues as though they were one and the same entity.

5. The ancillary business should adopt a policy of confidentiality substantially the same as the ethical obligation of confidentiality imposed on

lawyers. As it is, a nonlawyer agent owes his or her principal a duty of confidentiality, but in the event of litigation, communications between the principal and the typical nonlawyer agent are not protected from disclosure by an evidentiary privilege. Accordingly, the lawyer or law firm must be circumspect about the information that is shared with the personnel of the ancillary business.

6. Any referral of a law client to the ancillary business must be in the client's best interest, and the terms on which the ancillary services are provided must be fair and reasonable to the client.

7. Full disclosure to the recipient of the ancillary services is essential. This includes (a) the lawyer's or law firm's relationship to the ancillary business, (b) the client's reasonable alternatives for obtaining such services, (c) the affiliation and role of each person involved in the delivery of the legal services and the ancillary services, and (d) the effect on confidentiality and conflicts of interest.

8. The details of the disclosure should be confirmed in writing, and if practical, the client's signed consent obtained. Although Rule 4-5.7 merely states that the written advice "preferably" be in writing, the disclosure and advice always should be confirmed in writing, regardless of the degree of sophistication of the recipient.

Lesson Four

In the first four issues we have concentrated on “Who to Talk To” in your word-of-mouth marketing campaign. In this issue we will

discuss several ways to market your services to existing clients. This is called “cross-selling” and is one of the least expensive marketing options available to you. Why? Because you’ve already spent the time, money and effort to get the client in the door – there are minimal marketing costs associated with continuing to serve that client and therefore they are more profitable.

In cross-selling you educate your present and past clientele about your range of services, with the hope that they will want to use more of what you have to offer. This includes clients who might need advanced services in the same practice area you’ve served them in the past and clients who could be served by another practice area altogether.

Cross-Selling Your Client Base

Select past clients by looking at your client lists. If your client information is on a database that allows you to sort by given parameters or fields, it will be easy to generate reports or lists of those who meet specific criteria. If you are not that well organized, delegate a staff member to hand sort your files using your list of criteria.

For example, an Estate Planner could search for past clients that might need advanced estate planning services by sorting through the following criteria: age, asset level, past service provided by the law firm, whether the past client is a business owner, whether it is a family-owned business, etc. Develop similar lists of attributes that are reliable predictors of your client needs and then strategize about cross-selling or upgrading these groups. There is a great deal of hidden revenue to uncover in this process.

Once the sorting is complete, the next step is to re-establish communication with the targeted group of clients. There are several ways to do this, but most of our clients find that it is most effective to reconnect with a group by sending a letter. Add as much personalization as you can to your letter to increase its effectiveness – this should include the client’s name and perhaps a brief handwritten note which states something like: “I look forward to hearing from you,” or, “I have some

interesting new tools (or strategies) I’d like to discuss with you.”

Cross-Selling Letter #1

The following is a sample letter from a real estate attorney informing his client of further services provided by the firm and offering a complementary consultation. This letter is sent as part of the post-closing process – before the relationship with the client fades.

Sticklers Unite! Stamp Out Death by Comma!

The First in a Series (?)

A panda walks into a café. He orders a sandwich, eats it, then draws a gun and fires two shots into the air.

"Why?" asks the confused waiter, as the panda makes toward the exit. The panda produces a badly punctuated wildlife manual and tosses it over his shoulder.

"I'm a panda," he says at the door. "Look it up."

The waiter turns to the relevant entry and, sure enough, finds an explanation: "Panda. Large black-and-white bear-like mammal, native of China. Eats, shoots and leaves."

One would agree, would one not, that we lawyers should make proper use of the English language, even the version that Brits refer to as America's pernicious erosion thereof. Yes, I speak of good grammar. True, we sticklers for such things often are viewed as small-minded, anal-retentive twits. In this day and age, our culture is driven by self-justified Philistines ("Get a life!"), leaving well-educated, sensitive people weeping friendlessly in their caves. On the other hand, one must strive to retain whatever sense of proportion one can, which is why I thus far have refrained from complaining to Publix about its express check-out sign: "10 items or less." (It should be "fewer," not "less.")

Sticklers unite! Insist on proper grammar. Punctuation, for example, is meant to guide the reader through the passage, not merely decorate it with artistic abandon. Sadly, though, we are in the midst of a pandemic known to us Sticklers as "Death by

Comma." Take the widely seen traffic sign: CHILDREN DRIVE SLOWLY. One certainly hopes so. Or the supposedly improved version: CHILDREN, DRIVE SLOWLY, which undeniably is a worthy exhortation to those seven-year-olds driving around out there. Or: NO DOGS PLEASE, an indefensible generalization, given that many dogs do please and seem to make a point of it.

A comma may giveth or taketh away the meaning of an entire sentence. (See, for example, the famous – to us Sticklers – Panda

joke above.) Note the difference between the following two sentences: “The people in the line who managed to get tickets were quite satisfied.” “The people in the line, who managed to get tickets, were quite satisfied.” Everyone in the second line got tickets; not so the first. Or these two versions of a Biblical passage (Luke, xxiii, 43): “Verily I say unto thee, this day thou shalt be with me in Paradise.” “Verily I say unto thee this day, thou shalt be with me in Paradise.” Huge doctrinal differences hang on the placement of the comma, the latter passage being how Catholics interpret it (thus perpetuating the possibility of time in Purgatory) and the former being how Protestants interpret it (thus skipping over that whole unpleasant Purgatory business).

A particularly distressing practice is the routine (mindless) omission of the serial comma (the comma following the penultimate item in a series). For example, “red, white and blue.” As a general rule, a comma should precede and. The noble serial comma stands guard against the deadliest enemy of communication: ambiguity. Consider: “At the judicial reception, I spoke with President Farach, a scholar and a dilettante.” Did I speak with three people or just President Farach? Or: “Dedicated to my parents, Ayn Rand and God.” Although the reader is unlikely to believe that the writer’s parents are Ayn Rand and God, why subject oneself to unintended hilarity? The widespread disregard of the serial comma is the fault of newspapers, those purveyors of narrow-columned reading who began omitting the serial comma in prehistoric times (about 50 years ago) to save space. Granted, there are occasions when the serial comma can create ambiguity. For example: “Dedicated to my mother, Ayn Rand, and God.” Is the writer’s mother Ayn Rand? The serial-comma conundrum has been known to drive grown men to fisticuffs in editorial rooms and large law firms. (The use of “men” is intentional: women would never behave so immaturely.)

The key is to write with one’s brain engaged. Meanwhile, Sticklers unite! Down with grammatical libertines! Stamp out Death by Comma!

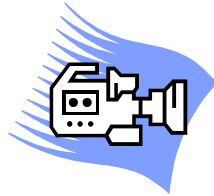
