Florida Statute section 48.27 allows the Chief Judge to establish an approved list of individuals designated as certified process servers, and these persons are authorized to serve initial nonenforceable civil process within the circuit. Florida Statute section 48.29(6)(b), provides that "return of service shall be made by a certified process server on a form which has been reviewed and approved by the court".

NOW, **THEREFORE**, pursuant to the authority conferred by Florida Rule of Judicial Administration 2.215, it is **ORDERED** as follows:

- 1. Certified process servers shall utilize and complete a form captioned "RETURN OF SERVICE", containing the following information:
 - a. The court, the case number and the caption of the case:
 - b. The date and time when process was received by the certified process server:
 - c. The date and time when process was executed;
 - d. A description narrative of the specific manner of execution (section of statute, if applicable);
 - e. The name of the person on whom process was executed:
 - f. If a person was served in a representative capacity, the position occupied by the person;
 - g. The signature of the certified process server;
 - h. The printed name and identification number of the certified process server; and
 - i. A statement that the person serving process is a certified process server, in good standing, in the judicial circuit in which the process was served.

- 2. A return of service form which contains additional information than required by part "A" above, shall not be invalidated on that basis.
- 3. Verification of the Return of Service shall be accomplished by either of the methods prescribed in section 92.525, Florida Statutes: a) an oath before a notary that, by personal knowledge, the facts and matters contained within the Verified Return of Service are true and correct; or b) a signed declaration containing the following language "Under penalty of perjury, I declare that I have read the foregoing Verified Return of Service and that the facts stated in it are true."
