ADMINISTRATIVE ORDER NO. 2.207-3/26\*

IN RE: REQUESTS FOR ACCOMMODATIONS UNDER  
THE AMERICANS WITH DISABILITIES ACT

The Americans with Disabilities Act of 1990 (ADA), 42 U.S.C. ' 12101 et seq., requires reasonable accommodations be provided to qualified persons with disabilities so they might participate fully in court programs, services, activities, and benefits. Florida Rule of Judicial Administration 2.540 requires specific ADA language be included in all notices of court proceedings.


**NOW THEREFORE**, in accordance with the authority vested in the chief judge by Rule 2.215 (b) (2), Florida Rules of Judicial Administration it is **ORDERED** as follows:

1. All summonses and communications noticing court proceedings, proceedings before general masters, and mediation proceedings shall include the following language which shall, be in bold face, 14-point Times New Roman or Courier font:

“If you are a person with a disability who needs any accommodation in order to participate in this proceeding, you are entitled, at no cost to you, to the provision of certain assistance. Please contact William Hutchings, Jr., Americans with Disabilities Act Coordinator, Palm Beach County Courthouse, 205 North Dixie Highway, West Palm Beach, Florida 33401; telephone number (561) 355-4380 at least 7 days before your scheduled court appearance, or immediately upon receiving this notification if the time before the scheduled appearance is less than 7 days; if you are hearing or voice impaired, call 711.”

2. The required language must also be provided in Spanish and Creole.
3. Spanish and Creole translations of the above notice are attached.
