President's Message



In Their Words: A Tribute To Patience Burns, The Matriarch Of The Bar

On February 27th, Executive Director Patience Burns announced her retirement (effective September 1) to the board of directors. Patience has literally and figuratively "set the Bar" during her 35 year

career with our Association, 25 as its Executive Director, leaving a legacy of excellence in leadership and stewardship. While she is our treasure, Patience has been admired by her peers far and wide as she helped build our Bar into the best county bar association in the state. There will be another day to formally recount and celebrate all of Patience's career accomplishments, but here are just a few:

*The Bar has seen its membership grow from 990 lawyers in her first year to more than 3,000 today.

*Hiring top notch, dedicated staff throughout the years.

*Patience created the first local bar website in the state (which won a national award just one year later) and has always kept our Bar ahead of the curve with regards to technology. Additionally, instead of having to share fees with a private vendor to handle our online CLE, she partnered with a local company to create our own in-house site.

*Patience accepted the Bar's responsibility of expertly administering a first of its kind residential mortgage foreclosure program in the 15th Circuit during the height of the Florida foreclosure crisis, which provided a tremendous benefit to the courts and citizens of Palm Beach County.

*Patience will be awarded the Suzanne Foley "Serving Justice" Award from the Legal Aid Society of Palm Beach County.

*Patience oversaw the Bar's acquisition of a vacated Denny's restaurant and its conversion into a first-class, and now debt-free, new home for the Bar.

*Patience was the first recipient of The Florida Bar's Marshall R. Cassedy, Sr. Award for exemplary service and extraordinary support of the legal profession. I know this award meant a lot to her as she worked for Mr. Cassedy while employed by The Florida Bar.

*Patience achieved the designation of Certified Association Executive by the American Society of Association Executives, of which less than five percent of all association professionals have achieved.

It has been a profound personal privilege to have had the opportunity to serve as President alongside one of the most well-known, well-liked and well-respected bar executives in the entire country.

Technology Corner

Introduction to Podcasts for Lawyers in 2016

If you have heard the word "podcast" in the last year, it likely arose because of *Serial*, a weekly show about a Baltimore murder trial. *Serial* was downloaded over 100 million times and its investigation sufficiently rattled

the Maryland court system that, 15 years after conviction, posttrial hearings began in February 2016. Consumers and advertisers are devouring this medium and podcasts have become a perfect tool for busy lawyers.

This article explains how to select and enjoy podcasts-ondemand. Each show is free and new episodes are pushed to you. After that, just press play.

A "podcast" is like a radio show comprised of individual episodes. The podcaster can be a professional broadcaster or just someone with a microphone and a topic. Often, a podcast may tell an ongoing story in a serialized format or it could be separate shows with guest interviews, current trends, and weekly round-ups. Most podcasts run 15 - 60 minutes and new shows are typically posted weekly.

On the iPhone, Apple has installed the Podcast app. Open the app and select "My Podcasts" on the bottom left of the screen. If you have not used Podcast before, you will see a blank screen. If you had previously used the app, any old shows may be listed; if you are not interested in those old shows, swipe from the right side to the left to delete. At this point, you should either have no podcasts or a group of podcasts which you want to keep. Let's fill in the rest of your library.

Hit "Top Charts" along the bottom right side of your screen. It will list the top 150 shows on iTunes. You can "subscribe" to a show in order to automatically receive new episodes as they are released. Likewise, you can download some or all previously released episodes. We will use two podcasts as examples in order to illustrate how this works.

First, find *Serial* on Top Charts (likely in the top 5), tap it, and then scroll down to Season 1, Episode 1. Hit the cloud-withan-arrow icon on the right side to download to your phone. You have just downloaded that *single* episode. Hit the "Subscribe" button towards the top right. Now that you have subscribed to the show, future episodes after today will be automatically delivered to your phone. You can unsubscribe anytime by hitting, "unsubscribe."

Second, tap "Top Charts" at the top left of the screen and let's pick another show. Find *Stuff You Should Know* (in the top 20), select it, scroll down to the episode, "Operation Mincemeat," and tap the cloud icon to download that episode to your phone. For now, do <u>not</u> subscribe.

Hit "My Podcasts" on the bottom left and you will return to your library of *Serial* and *Stuff You Should Know* which are now on your phone. Select Serial and it should show you the episode you downloaded. Notice there are two buttons in the middle of the screen: "Unplayed" shows the episodes <u>on your phone</u>. "Feed" is the complete list of episodes <u>in the cloud</u> which you can download to your phone. Since you need to listen to *Serial* from the beginning, hit Feed, scroll down to Season 1, Episode 2 and tap the three dots to download that episode to your phone. Tap Unplayed (upper left) and you will see that you now have two *Serial* episodes on your phone. If you enjoy *Serial*, go back to Feed and download the remaining episodes to catch up. Again, future episodes will automatically be delivered since you already subscribed.

But you did <u>not</u> subscribe to *Stuff You Should Know*. You just downloaded one episode. Unlike the ongoing saga of *Serial*, you can pick and choose episodes of *Stuff You Should Know* which interest you. To add episodes, go back to Feed and download the episodes you like (or go ahead and subscribe). You are ready to listen.


When you play an episode, it will fill the entire screen: there is a volume bar, time remaining indicator, play and pause buttons, and the ability to jump forward or backwards 15 seconds. A faint circle and downward arrow is in the upper left corner. Tap that and it brings you back to the list of episodes. You can swipe from right to left to delete an episode (likewise, in My Podcasts, the same swipe will delete the entire podcast from your library).

Some fine tuning: inside your library, tap a podcast to see the list of unplayed episodes. There is a cog wheel icon above Feed. Tap that to refine settings for that podcast. Likewise, delete old episodes to save space on your device.

To find law-related podcasts, hit Search in the bottom right corner. Search for shows like ABA Podcasts, Above the Law, Bloomberg Law, Florida Bar Podcast, Lawyer 2 Lawyer, Lawyerist, and Legal Talk Network. You can also search for keywords like "Florida law" or "injury law." When you find something you like, subscribe and/or download individual episodes.

You might also try podcasts about sports, news, hobbies, or topics of interest. Try *Bob and Chez* (politics), *Mike O'Meara* (humor), *Slate's Political Gabfest, Reply All, TEDTalks, Welcome to Night Vale,* and *WTF with Marc Maron.*

Voluntary Dismissal Of A Guardianship — The Pendulum Swings!

In *Gort v. Gort*, 2016 Fla. App. LEXIS 1448 (Fla. 4th DCA 2/3/16), the appellate court, in distinguishing *Jasser v. Saadeh*, 97 So. 3d 241 (Fla. 4th DCA 2012), held that a party **can** voluntarily dismiss a petition to determine incapacity.

In Gort, the petitioner petitioned to have his brother found incapacitated and for appointment of a limited guardian and emergency temporary guardian. The brother and his cousin opposed the petition. The cousin petitioned to determine the brother's incapacity and sought to be appointed plenary guardian of his person and property. The trial court entered an order setting an incapacity hearing, appointed counsel for the brother, and appointed a three-member examining committee. All three members found the brother was incapacitated and lacked the capacity to contract. Prior to the incapacity hearing, the court referred the parties to mediation. All parties participated and were represented by counsel. The meditation resulted in a settlement agreement, in which the petitioner and the cousin would dismiss their pending petitions without the need for prior court approval. Pursuant to the agreement, the petitioner and cousin voluntarily dismissed their petitions. Over one year later, the petitioner filed an action against the brother and cousin in the probate division seeking a declaration that the settlement agreement was valid and enforceable. The brother responded by filing a counter-petition seeking to have the agreement declared invalid and unenforceable. The trial court enforced the settlement agreement.

On appeal, the brother and cousin argued, in part, that the trial court erred in enforcing the settlement agreement because it is void under Florida law and public policy. Specifically, they argue the petitioner cannot voluntarily dismiss his petition without the statutorily required adjudicatory hearing on the brother's incapacity, citing *Jasser v. Saadeh*, 97 So. 3d 241 (Fla. 4th DCA 2012).

The appellate court, in affirming the trial court's order enforcing the settlement agreement, reasoned in part:

While the rules are silent on whether a petition can be voluntarily dismissed prior to an adjudicatory hearing, common sense dictates that a petitioner has that ability. Katke v. Bersche, 161 So. 3d 574 (Fla. 5th DCA 2014), is helpful. There, in ruling on a petition for a writ of prohibition, the Fifth District implicitly recognized the voluntary dismissal of a petition to determine incapacity prior to an adjudicatory hearing. Id. at 575-76.

"A party may voluntarily dismiss any claim, and such a dismissal, if accepted by the trial court, deprives the court of jurisdiction over the subject matter of the claim dismissed." Cutler v. Cutler, 84 So. 3d 1172 (Fla. 3d DCA 2012). The plaintiff's right to voluntarily dismiss its own lawsuit is almost absolute, with exceptions for fraud on the court and child custody. Tobkin v. State, 777 So. 2d 1160, 1162 (Fla. 4th DCA 2001). Id. at 576. * * * *

[In *Jasser v. Saadeh*] [w]e distinguished a voluntary dismissal from an agreed settlement and mutual dismissal. Id. We then discussed the importance of insuring that the person alleged to be incapacitated is protected. Id. at 247-48. We did not hold that a person cannot voluntarily dismiss a petition once filed.

While the policy discussion in Jasser supports the brother and cousin's position, the facts and issue in Jasser were different from this case. Here, the brother is not suffering from Alzheimer's, but has a mental health disorder, which appears controllable when properly medicated. The brother attests to that fact. Instead of proceeding with the adjudicatory hearing, the trial court sent the parties to mediation to resolve their dispute. They resolved it, and the brother did not complain about the settlement agreement until more than one year after dismissal of the petition to determine incapacity.

Although three examining committee members concluded the brother lacked capacity to contract in June 2012, the reports were never considered at a formal adjudicatory hearing. And, there was never a trial court determination that the brother was incapacitated. In fact, the brother maintained that he was NOT incapacitated.

Because our guardianship and probate rules do not prohibit a party from voluntarily dismissing a petition to determine incapacity, and section 744.331 does not mandate an adjudicatory hearing, the trial court did not err in finding the settlement agreement did not violate Florida law or public policy.

In Mediation, One Size Does Not Fit All: How to Customize Your Mediation

Imagine yourself in Bloomingdale's, looking at a rack of designer suits, on sale today for only \$500, but they're nonreturnable. The salesperson assures you that these new suits are "one size fits all". Just pick out the color, and you're done. You're skeptical, but this is a reputable store and you're in a hurry, so you buy one. You take it home and put it on, and your 40-short body is now swimming in 48-long fabric. Ridiculous, right? You wouldn't buy a suit that way. Suits need to be customized, tailored to fit. So do mediations. So why would you spend your client's money on the whole mediation process without ensuring that what you're buying is going to fit your case and the particular needs of your clients?

How can your mediation be customized? Start with choosing the right mediator. Here are some examples of the choices you have. If you have a construction defect case, would you choose a mediator who specializes in personal injury cases, because he's cheap and available? Probably not. But if the loss is covered by insurance, and the PI mediator has experience in dealing with adjustors, maybe you would. If your case is about a trustee's malfeasance that might be a breach of fiduciary duty, would you hire a family law mediator with no experience in trust litigation? Maybe not, but what if the mediator is known for being smart, a quick study, and for developing rapport with elderly parties like your client who come to the mediation feeling betrayed by their children?

Undoubtedly, there are some types of cases that require subject matter expertise. Mediators in securities fraud and stockbroker malfeasance cases, complex business relationship issues, and complex marital dissolution cases, for example, probably should be chosen primarily for their practice expertise and experience. But it could be a good idea to cross practice lines and choose a mediator for his or her personality and people skills if your case, or the parties, warrant it. You can choose a mediator whose personality will engender empathy in your client, or who will not be so abrasive that your client will be offended by his manner. A "tough" mediator who will "talk sense" into your client, or the other side, is not going to be effective if the personalities don't warrant that kind of approach. Selecting the right mediator is critical to the process of customizing your mediation.


Once the mediator is chosen, the simplest and most direct way to customize your mediation is to educate your mediator. Schedule a confidential pre-mediation conference or phone call with the mediator; don't wait for the caucuses to begin the process. By the time you reach mediation, you should well know your client's personality and what kind of approach would work best with her. Let the mediator know about it in advance. Learn from your client what her real interests are in the case. Tell the mediator what your client really wants from the case, even if it's not something the Court could grant based on the pleadings, and encourage the mediator to think outside the box to try to get it for you. Give the mediator a confidential mediation statement, in advance of the mediation conference, that includes not just the pleadings and the client's financial settlement position, but also some of the background that provides insight into what is driving the dispute. Give the mediator a hook to hang a settlement on.

Finally, do not minimize the importance of an atmosphere of civility in the mediation. Civility is at the heart of the mediation process. It allows for listening instead of just reacting. It keeps submerged the emotional impediments to the focus on solutions. All of your efforts to tailor the mediation to suit the particular needs of your client and the circumstances of the case will be wasted unless the inherent hostility of the litigation is kept in check. Do not skip the opportunity to make an opening statement, and use it to set the tone. Listen to what the other side is saying for clues as to what it will take to get the case settled. Keep the "we will bury you" rhetoric out of your opening. Talk directly to the opposing litigants, and focus not on why they will lose, but on why the case should be settled.

You have the ability to make your client's mediation a custom fit. Make it a worthwhile purchase, not just a bargain.

Medicare and Medicaid Benefits are not Admissible as Collateral Sources

In *Florida Physician's Insurance Reciprocal v. Stanley*, 452 So. 2d 514 (Fla. 1984) the Supreme Court concluded that Fla. Stat. 768.76(1), Fla. Stat. (2014) required the admission into evidence of all

collateral sources which were available to the plaintiff free of charge. At 516 the Court held

[E]vidence of free or low cost services from governmental or charitable agencies available to anyone with specific disabilities is admissible on the issue of future damages... Such evidence violates neither the statutory nor the common-law collateral source rule and does not, therefore, require a new trial.

We believe that the common-law collateral source rule should be limited to those benefits earned in some way by the plaintiff. Governmental or charitable benefits available to all citizens, regardless of wealth or status, should be admissible for the jury to consider in determining the reasonable cost of necessary future care. Keeping such evidence from the jury may provide an undeserved and unnecessary windfall to the plaintiff.

The *Stanley* opinion has been difficult to apply. Exceptions to its application have been frequently made. In *Gormley v GTE Prods. Corp.*, 587 So. 2d 455 (Fla. 1991) the Court held that Stanley did not apply to homeowner's insurance benefits because plaintiffs had paid for the insurance. In *Nationwide Mut. Fire Ins. Co. v. Harrell*, 53 So. 3d 1084 (Fla. 1st DCA 2010) the Court concluded that Stanley did not apply to allow the admission of payments made by private health insurer. In *Weaver v. Wilson*, 532 So. 2d 67 (Fla. 1st DCA 1988) the Court declined to apply *Stanley* to employer benefits.

In Joerg v. State Farm Mut. Auto. Ins. Co., 176 So. 3d 1247 (Fla. 2015) the Court was faced with the question of whether future Medicare or Medicaid benefits were admissible. In the District Court case of State Farm Mutual Automobile Insurance Co. v. Joerg, 38 Fla. L. Weekly D1378 (Fla. 2d DCA June 21, 2013) the Second District applied Stanley to reverse a jury verdict where the trial court had refused to allow the defendants to place future Medicare benefits in evidence. The Second District concluded that under Stanley these benefits constituted free or low cost services from a governmental agency and were thus admissible under Stanley. In Joerg, supra, the Florida Supreme Court receded from Stanley and held that future Medicare and Medicaid benefits are not admissible in evidence and, indeed, that all social legislation benefits fall in the collateral source category and should not be admitted in evidence. In *Joerg* the Supreme Court reviewed the steps taken by Medicare to require reimbursement when the plaintiff obtains an award which includes the medical benefits for which he or she obtained benefits through Medicare. At 1254, the Court holds:

Regardless of whether an individual has directly paid for his or her Medicare benefits, a factual matter which is unclear from the record before this Court, all Medicare beneficiaries who receive an award for future medical damages will be liable to reimburse Medicare, if Medicare makes a conditional payment on their behalf. Therefore, the assertion by State Farm that any Medicare and Medicaid benefits provided to Luke are free and admissible under *Stanley* is unsupported under the law.

The reasoning behind this decision is that where the right of reimbursement exists as it does with Medicare and Medicaid, there is no windfall to the plaintiff by recovering for those damages without allowing the jury to know about the Medicare or Medicaid benefits. The Court concluded that it is inherently prejudicial to permit admission of evidence showing that plaintiff has obtained a governmental benefit and there is no certainty that payment under governmental programs will, in fact, occur. At 1255, the Court holds:

Moreover, it is absolutely speculative to attempt to calculate damage awards based on benefits that a plaintiff has not yet received and may never receive, should either the plaintiff's eligibility or the benefits themselves become insufficient or cease to continue. Even where very particular benefits exist, extensive waiting lists may prevent an individual from actually receiving the benefit. The continued existence and sufficient funding of public services depend upon legislative action, which is by no means a predictable matter. "To encourage juries to mitigate damages based on tenuous public resources forces plaintiffs, like the foolish house builder in the parable, to rebuild lives on shifting sands. The floods may come, and the winds blow, and great will be the fall." Cates v Wilson, 361 S.E.2d 734, 739 (N.C. 1987) In cases that involve presumptive Medicare reimbursements, it is even more speculative to anticipate a reduction of future damages because the structure of the MSPA is intended to prevent Medicare from paying if there is forthcoming payment from a primary payer. See Cochran, 291 F.3d at 777-78.

Finally, to consider Medicare, Medicaid, and other similar social legislation benefits as exceptions to the general rule that precludes admission of collateral sources circumvents the purpose of the collateral source rule. It is a basic principle of law that tortfeasors should not receive a windfall due to benefits available to the injured party, however those benefits were accrued.

This opinion clarifies the inadmissibility of Medicare and Medicaid payments as collateral sources and precludes the admission of those benefits in a personal injury suit.







The Palm Beach County School District serves over 150,000 students. Palm Beach County is one of the largest and equally most successful school districts in Florida. We have raised graduation rates and the future looks rosy for most students. Occasionally within our system, students have been

accused of violations of the student code of conduct for which a principal may request that the student be expelled from the general education setting. Based on school board policy¹ and Florida law², a school Principal has the authority to request that a county School Board expel a student from school, based on certain serious conduct that is alleged to violate the School Board's Policy.

When students are expelled in a school district, they are entitled to due process. In the event a principal is seeking expulsion or removal from the general education setting, a heightened due process applies³. Currently in the Palm Beach County School District, if a principal recommends that a student be expelled, the student will be provided a fact finding hearing pursuant to FS §120.57. Hearings are generally held at the school site (expelling school) and presided over by a volunteer administrative judge. During these hearings, a student has the right to request to be represented by Counsel. The School District, in connection with the Legal Aid Society of Palm Beach County, works with parents and gives them information to help the parent locate an attorney who will represent the student on a pro bono basis. We are working toward a system in which an attorney will be assigned to represent each student facing expulsion. The importance of having an attorney look at the facts and circumstances of the case and advise the parent accordingly must never be minimized. The attorney will provide an invaluable service in assisting students and their parents obtain a just outcome.

Attorneys are needed to volunteer to assist in protecting the rights of these students and to make certain that the process is followed in accordance with Palm Beach County School Board Policy, Florida Statutes, and case law. Give your time and your talent to help the Legal Aid Society and the Palm Beach County School Board safeguard the rights of our students. If you will agree to accept at least two assignments per year you will enrich the educational experience of our children. Over one hundred students and their chaperones packed the South County Courthouse for the First Annual Youth Law Day on January 9, 2016. This unique all-day event, showcasing local judges, attorneys, and others with law-related careers, was organized by the Law Related Education Committee and the 15th Judicial Circuit State Attorney, with support from the Ward Damon law firm and Rock Legal.



The day began with Judges Jeffrey Gillen and Samantha Schosberg Feuer answering questions about the judicial branch and running the students through a sample jury deliberation. Jason Lazarus Receives the Florida Bar President's Pro Bono Service Award



Jason Lazarus was awarded the 2016 Florida Bar President's Pro Bono Service Award for the Fifteenth Judicial Circuit. This award's purpose is twofold: "to further encourage lawyers to volunteer free legal services to the poor and to communicate to the public a sense of the substantial volunteer services provided by Florida lawyers to those who cannot afford legal fees." The award was given at a ceremony before the Florida Supreme Court in January.

Since joining Holland & Knight in 2001, Jason has provided more than 900 hours of pro bono service. In Jason's most recent and difficult case, an excessive use of force case, he spent more

than 200 hours on it and obtained a settlement on behalf of the client. The settlement was higher than any other use of force settlement paid by that particular agency since 2005. The firm did not keep any portion of the settlement for attorneys' fees, and instead remitted all of the settlement funds, less some minimal costs incurred by the firm, to the client.

In addition to his direct representation, Jason is a source of advice and counsel for many staff attorneys at Legal Aid. In the words of John Foley, Esq., Supervisor of the Non-Profit Legal Assistance Project at Legal Aid, "Jason is one of the most knowledgeable attorneys I have worked with in my 27 years of practice. What is even more impressive is his willingness to assist legal aid clients. I can hardly think of a time when Jason hasn't had a pro bono case. Regardless of how difficult, complex or "last minute" Jason never says no.

Jason's dedication to providing pro bono legal representation carries on his firm's long standing commitment to doing pro bono work and sets the example for the legal profession.'






