For any of the positions, it is the candidate's responsibility to verify ahead of time through the Bar office that the members that are signing their petitions are members in good standing, otherwise, the petition will be deemed invalid.

## Judicial Luncheon — Voir Dire

On September 30, 2009, numerous members of the Palm Beach County Bar Association ("PBCBA") attended the first of a series of monthly judicial luncheons organized by the Judicial Relations Committee of the PBCBA. Judge Garrison, Judge Colbath, Judge McCarthy, and Judge Lewis participated in the panel discussion. The luncheon was held in the Judicial Dining Room and was comoderated by Larry Rochefort, Esq.; Michelle Suskauer, Esq.; Lloyd Comiter, Esq.; and Laurence Brownstein, Esq. The participating judges shared the following valuable insights on voir dire:

- 1. Cases can be won or lost in jury selection, and it is vital to eliminate jurors who will not be fair.
- 2. A judge should talk to the jurors prior to the start of voir dire and try to make the jurors feel comfortable answering even awkward questions truthfully. Prospective jurors should be reminded that they are not going to get in trouble for honestly stating their opinion.
- 3. Leading questions in voir dire are generally okay - an objection on the basis of "leading" will generally not be sustained.
- 4. Jury selection can be very timeconsuming in the circuit civil division.
- 5. An effective technique in jury selection is to listen to the people on the jury panel - let them talk instead of giving a speech to them; many attorneys in voir dire are not listening to the answers given by the jurors.
- 6. If a juror states that he/she doesn't feel comfortable answering a potentially awkward or embarrassing question, that person should be given an opportunity to respond to the attorneys and judge privately. Some judges have this private question and answer session after questioning of the others is complete, so that the flow of voir dire is not interrupted.
- 7. Jury questionnaires can be used they can be especially beneficial in lengthy trials to show which people would have a financial hardship from serving for a long time.
- 8. Judges should protect jurors from aggressive questioning by attorneys or from criticism of a juror by an attorney.

- 9. The Florida Supreme Court has issued an order limiting the number of jurors on a panel to 16 for civil cases; this order provides that you must choose your 6 jurors from the panel of 16. There is a local rule that says you can double that number in a lengthy case, but if a lawyer wants extra people on his or her panel, the lawyer must make a request to the presiding judge, and the judge needs to file a petition with the chief judge at least 3 weeks in advance of the trial date to request a larger panel. Attorneys may want to rethink their voir dire strategy in light of the limited size of the jury panels, because if you go through the potential jurors on the panel you are given without selecting a jury, you may be rolled to the next trial docket.
- 10. Jury selection is now sometimes being started on Thursdays or Fridays because of limited space for jurors in the main jury room.
- 11. Some judges do not like the "what kind of bumper sticker do you have" question but it seems to interest jurors.
- 12. It can be effective to write out your voir dire questions in advance, and to get comfortable with them ahead of time. It is effective to use plain, simple language in your questions, and to make them precise. Too many times, lawyers use phrases like "damage caps," "tort reform," and "insurance crisis", and many people on the jury don't know what they are talking about. Instead of asking a question such as "do you believe in damage caps?", try to make it simpler by instead asking something like "is there a number in your head that you wouldn't feel comfortable awarding more than in terms of damages?"
- 13. Some judges believe that you should try to keep voir dire brief; you want to get a fair jury and questions should be directed to that goal. Jurors seem to want to get on with hearing the evidence and rendering a decision.
- 14. One tip is to turn trial boards away from the jury during voir dire, and remove any other distracting items. If the jurors can see those items during voir dire, they may focus on them and be less attentive to the questioning.

- 15. Make sure you don't have anything set up like projectors with cords that could present a tripping hazard to jurors; make sure jurors have unimpeded access to go where they need to.
- 16. Consider requesting individual voir dire in the jury room on "hot button" issues, where one person's answers could have the effect of tainting the entire panel (issues such as tort reform, medical malpractice, etc.). For individual voir dire, you can bring the juror and the attorneys into the jury room. This is likely more time consuming, but can help avoid having to dismiss the entire panel.
- 17. One of the most important questions to ask a juror is "can you keep an open mind?"

Judge Kastrenakes vows to be a judge known for his

preparation and his respect for the lawyers and their clients in his courtroom.

Judge Kastrenakes is not alone in his love for the law. His wife, Pia, is a practicing attorney, and Judge Kastrenakes swore in his oldest child, Eleni, during his own investiture ceremony in October. Eleni will begin her legal career with Holland & Knight in Miami. Judge Kastrenakes' middle child is an investment banker in Atlanta and his youngest is a senior at UNC-Chapel Hill. Off the bench Judge Kastrenakes is an avid

follower of Gator football, making the trek to Gainesville several times each Fall. When the Gators aren't playing Judge Kastrenakes enjoys playing golf and reading military history.

## **Armed Services Advocacy Project**

# LEGAL AID SOCIETY AND FLORIDA POWER AND LIGHT INITIATE JOINT PROJECT TO ADDRESS FORECLOSURE CRISIS

The Legal Aid Society's Pro Bono Program, in conjunction with Florida Power and Light, is pleased to announce a pilot project to address the current foreclosure crisis and the demand for assistance that far outweighs the resources available. In response to the overwhelming request for services from people who have been served with foreclosure papers the Legal Aid Society approached the in house counsel at Florida Power and Light about the possibility of assisting Legal Aid in responding to this need. The project, spearheaded by attorneys Robert Sendler and Ellen Malasky, with the full support of General Counsel, Charles Sieving, is slated to start in January 2010. The project will begin as a clinic with FPL attorneys coming to the Legal Aid offices one evening a month and meeting with clients who have been served with foreclosure papers. The attorneys will assist them in filling out answers and help them to understand the foreclosure process. Several other possible options for participation by the FPL counsel will be explored from actual case representation to intake assistance. On November 19th over 40 FPL attorneys attended a two-hour training on foreclosure and bankruptcy given by Legal Aid attorney Tequisha Myles and private attorney Alan Crane.

The FPL project is the perfect local launch for the statewide "One Campaign," One Client, One Attorney, One Promise, initiated by the Supreme Court's Standing Committee for Pro Bono the One Campaign gives attorneys the opportunity to renew their promise to never reject the cause of the defenseless or oppressed. Through the One Campaign, attorneys are encouraged to take one case in which they can utilize their unique skills to help regular citizens navigate the law. ## Professionalism

## Re-Examining Our Roles as Counselors

Rather than give you a lecture on some topic of professionalism, I instead offer a couple of scenarios, intended to provoke some thought and perhaps generate discourse. In thinking about these, be honest with yourself. No one is looking over your shoulder or sending your answers to the bar. This is intended to draw attention to some important, but often overlooked, professional responsibilities inherent in the practice of law. With each scenario, ask yourself to identify the issues presented. Are any "real" issues worthy of attention? What do I do with this, if anything?

Client hires you in a case with a vitriolic and often public history. Client has clear goals to not only win, but also to destroy the opponent. Being a litigator, you relish the idea of a confident client who will pay your rate, won't cap your hours and provides the added bonus of a little media attention for your practice. Client wants you to use all means necessary to inconvenience the opposition. Client instructs you to take depositions "everyone", including many who do business with the opposition and to set the depositions at the farthest end of the county. Client also wants separate motions and separate hearings on every issue raised during litigation.

Client refuses to tender certain document requested in discovery. Client informs you that if he does tender the documents, the result will be exposure of assets and income, which have been secreted, including from the IRS. Client is concerned that such exposure will not only hurt his case, but may expose him to criminal liability for tax fraud.

Now a little food for thought:

This situation exemplifies the "scorched earth" type of litigation, which has become increasingly common. Using every means available to make your opponent surrender, although lawful and perhaps technically permitted, is nevertheless contrary to professional behavior and may subject an attorney to sanctions. The "golden rule" seems applicable here too. But there is more than that, since as a profession, we have an obligation to use the law for legitimate purposes and "not to harass or intimidate others." Preamble to Rules Regulating the Florida Bar. One could argue that such broad discovery is permitted, and it is up to the opposition to seek a protective order, but this argument misses the point. In a case such as this, the lawyer should confront the client about the limits of professional conduct, since no client is worth destroying your reputation. Moreover, Rule 4-1.4(a)(5) requires a lawyer to consult with his or her client when the lawyer's conduct is limited or if the client expects conduct from the lawyer in contravention of the rules. Permitting ourselves to be used in such a manner demeans us as individuals and hurts the profession as a whole. The question in our minds should not be whether the action will result in personal trouble for us, but whether it is the right thing.

This scenario is fairly common in family law actions, but is likewise applicable to civil matters, especially actions involving joint owners of a business or partners in investments. The first question which may arise is whether you have a duty to the IRS. The short answer is no, since you still have a duty of confidentiality to your client and cannot divulge past criminal conduct disclosed by a client. However, problems may arise if the client continues to engage in the criminal conduct or engage in behavior which perpetrates a fraud upon the court. Clearly, the attorney has a duty to tender proper discovery under the rules. But in this instance, the client is refusing to tender the documents to you and has told you of his purpose for withholding them. The client should be counseled regarding his action of withholding the documents in contravention to the court rules (see #1 above), and failing that solution, the lawyer should likely withdraw. Rule 4-1.16(a)(4) mandates withdrawal when "the client persists in a course of action involving the lawyer's services that the lawyer reasonably believes is criminal or fraudulent, unless the client agrees to disclose and rectify the crime or fraud."

The above examples are just a couple of situations arising with some frequency in litigation. Although the choices may not be clear for the attorney faced with difficult clients and difficult situations, must can be gained by following your gut instinct. Does it feel wrong? Ask yourself, would I be angry if the opposition litigated against me in this manner? Do I want to be known as the lawyer with no respect for the truth? By periodically going through some self analysis, we can better ourselves and provide better counsel for our clients. And of course, we act as true professionals, not just bullies with law degrees, and this will benefit all of us.

## Probate Corner



## Personal Jurisdiction — Service by Formal Notice or Summons?

Section 731.301(2), Fla. Stat. states that "[f]ormal notice shall be sufficient to acquire jurisdiction over the person receiving formal notice to the extent of the person's interest in the estate." [emphasis added].

## I. Who has a sufficient "interest in the estate" for purposes of service by formal notice?

Service by formal notice is only effective on parties interested in an estate. These parties include, but are not limited to, beneficiaries, claimants, and personal representatives. *See* Galego v. Robinson, 695 So. 2d 443 (Fla. 2d DCA 1997).

In <u>Payette v. Clark</u>, 559 So. 2d 630 (Fla. 2nd DCA 1990), the court held that in a closed estate, the former personal representative and beneficiaries had a sufficient "interest in the estate" under this section, regarding claims for relief within the jurisdiction of the probate court. The court reasoned:

At the inception of the probate proceedings the appellee Theodore W. Clark, by obtaining appointment as personal representative, submitted himself to the jurisdiction of the court for all purposes, including the resolution of the issues raised by this petition. The appellees Carter S. Clark and Shirley Lorraine Warner filed consents to his appointment with requests that he be permitted to serve without posting bond. All appellees accepted distribution of the estate assets, thereby availing themselves of the judicial powers of the Florida court, and filed receipts and consents to the discharge of Theodore W. Clark as personal representative. Additionally, the petition alleges that all the appellees had knowledge of the existence of the appellant and knowingly appropriated her interest in the estate assets. We conclude that this participation in the estate process by the remaining appellees is sufficient to constitute a voluntary submission to the jurisdiction of the court for the purpose of determination of counts one through four of the petition. [citations omitted]

Parties in possession of estate assets that had been improperly distributed by the personal representative could be served by formal notice. *See* Hall v. Tungett, 980 So. 2d 1289 (Fla. 2nd DCA 2008). In Hall, the court found that the following allegations in the personal representative's motion sufficient to support service by formal notice:

The PR's motion alleged that the brokerage account was titled in the decedent's name at the time of his death, was wrongfully distributed to Ms. Hall by Ms. Green as the predecessor personal representative, and was in Ms. Hall's possession. The motion claimed that the account and other property belonged to the Estate and must be returned to it, or if the account and property were no longer in Ms. Hall's possession then she had to return to the Estate the equivalent value, as well as any income earned on the assets or any gain received with respect to the assets.

## II. Who does not have a sufficient "interest in the estate" for purposes of service by formal notice?

If the litigation is to determine whether the estate, in the first instance, had an interest in the assets, then service of process on the party in possession of those assets must be by summons. *See* <u>Hall v. Tungett, supra.</u>

A person who has no claim to estate property, and who does not otherwise claim any right to participate in the administration of the estate, does not possess an "interest in the estate" under s. 731.301(2). In re Estate of Vernon, 608 So. 2d 510 (Fla. 4th DCA 1992), involved an estate where the personal representative sued defendants claiming that shares of stock in a bank previously held in one of the defendant's names were in truth owned beneficially by the decedent, and therefore should have been marshaled into the probate estate, rather than being liquidated by the defendant outside the estate. The court held that the probate court could not obtain jurisdiction over the defendants by formal notice, and that the estate's remedy was to institute an ordinary civil action against the defendants.

In <u>Galego v. Robinson</u>, 695 So. 2d 443 (Fla. 2d DCA 1997), the court held that the probate court lacked jurisdiction over appellant, who allegedly damaged the estate through mismanagement of the decedent's assets using the decedent's power of attorney. The appellees should have instituted a normal civil action against appellant for any mishandling of funds under the power of attorney.

In Kountze v. Kountze, 2009 Fla. App. LEXIS 15621; 34 Fla. L. Weekly D 2142 (Fla. 2nd DCA 10/16/09), appellee personal representative filed a petition against appellants, a decedent's former wife and a remainder beneficiary of a trust, to determine the whereabouts and the value of missing estate assets. The PR served the appellants with a notice of the personal representative's taking possession of assets of the estate; the notice was served by formal notice. In the notice, the PR alleged that he had taken possession of certain assets which had been listed in the trust. The court held that the formal notice that the appellants received in the estate proceeding was not sufficient for the trial court to acquire personal jurisdiction over them. The court reasoned:

An interested person is defined in the probate code as "any person who may reasonably be expected to be affected by the outcome of the particular proceeding involved." § 731.201(23). However, the meaning of interested person "may vary from time to time and must be determined according to the particular purpose of, and matter involved in, any proceedings." Id.

The appellants contend they are not interested persons within the meaning of section 731.201(23). Specifically, they disclaim any interest in the estate assets. Our understanding of appellants' position is that the assets in question are trust assets that are separate and distinct from the estate assets and therefore they would not "reasonably be expected to be affected by the outcome" of the estate proceedings. § 731.201(23). If that assertion is true, then the formal notice they received in the estate proceedings was not sufficient for the trial court to acquire personal jurisdiction over them.
