Technology

When You Whisper Sweet Nothings to Your Computer, Speak Clearly

(Special Note B the text which appears in this article inside brackets [] represents a mistake made by the dictation software. To help demonstrate how well the software works, I have left all of those mistakes in the text)

Sometime in the early 1990s, I attempted to use speech recognition software in my practice. At that time I decided that the software was not ready and did not help me significantly in my practice. The installation and training procedures for the software were far too [to] complicated [comp can], the computer technology at the time was not fast enough, and the amount of RAM that computers could handle was far too small. At a recent seminar at which I spoke, one of the questions was whether speech recognition technology was useful. Since I had not looked at it in the past five years, I thought that it was time to give the software another try.

My first step was to use the free speech recognition software which comes with Microsoft Office XP. I went through a short 15 minute training session and after that found that the accuracy was good, perhaps 85%. I was so encouraged by these results that I decided to spend \$200 to purchase the newest version of Dragon NaturallySpeaking (version 8) which is now owned by ScanSoft

(http://www.scansoft.com/naturallyspeaking/). Although there is a [any] Legal Edition of the software (which sells for approximately \$960.00), I opted to go with the Preferred Edition instead since this was only an experiment. I also chose to use Dragon NaturallySpeaking Preferred Version 8 instead of the IBM ViaVoice (IBM, \$160.00) because the limited information I could find on either product indicated that Dragon NaturallySpeaking was more accurate. I have no personal information to judge the accuracy of the IBM ViaVoice product. Another important part of this puzzle is that my computer is a new Dell laptop, Pentium M 1.7 GHz with 1 GB RAM.

The training procedure was essentially the same as the training that I did for Microsoft Office XP speech recognition. I read perhaps 15 minutes of text to the computer and then it analyzed my speech patterns and I was able to begin dictating. At first, the accuracy rate was between 90 and 95%, which encouraged me even further. I found that I could increase the accuracy rate by changing the way I spoke as well. When I dictate to the computer, I now try to enunciate each word more clearly than I do in ordinary speaking. Perhaps this will improve my conversational skills. By going through a second training session, which was again approximately 15 minutes,

I was able to improve the accuracy of the program even further. I find that the software is now more than 95% accurate. I have now been using the software for three months and I've decided that it is extremely useful. The Dragon NaturallySpeaking product allows me to dictate into most programs and is not limited to Microsoft products. I can also dictate instructions, such as screen commands. After only two weeks I got [gone] to the point where I no longer want to type at all. Whenever I catch myself typing more than four words I stop [stopped], pick up [pickup] my microphone, and turn on the software. It is undoubtedly much easier than typing and, for most people, it will be faster as well.

Another option that the Dragon NaturallySpeaking product gives [give] you is the ability to dictate into a personal recorder [record or] which is then plugged into the computer and downloaded. This is similar to using a hand-held tape recorder to give dictation. Instead of having someone listen to your tape and transcribe it, however, the computer listens to your recording and transcribes it. I spoke with an attorney at the courthouse who has used the hand-held recorder exclusively for approximately 1 month and said that he hopes no one ever asks for it back.

The major shortcomings of the program all concern [concerned] its inability to handle legal terms and case citations. Of course, most of those problems would be resolved if I wasn't so cheap and would spend the money for the legal version of the software. I would also expect that transcription of documents which contain medical terminology might also cause [calls] a problem unless you are using the medical version of the software.

As for the accuracy of the software that I purchased, you can see from the number of mistakes in this document that the accuracy rate is very high. Out of [loud] 880 words I dictated for this article, the software made 11 mistakes. That's a 98.75% accuracy rate. The good news about making mistakes is that the software learns from its mistakes and gets better all the time. The accuracy this week is much better than the accuracy during my first week.

As a result of my experiment, Dragon NaturallySpeaking Version 8 Preferred has become a necessary addition to my software lineup. If you're considering trying this product in your practice, or perhaps IBM ViaVoice, feel free to call me or e-mail me to get an update on my progress. bdr@flappellatelaw.com.





2005 ABA ANNUAL MEETING REPORT: CHICAGO

I complained about the lack of business at the mid-year meeting last February in Salt Lake City. If you hear me make that complaint again – kick me. The House of Delegates crammed four days worth of business into two in Chicago.

Monday started with a 7:30 a.m. meeting of the Florida delegation. During this caucus the Florida Bar delegates, led by Ben Hill, outlined the official Florida Bar position on most matters expected before the House. The local delegates, such as myself, are free to vote as we have been instructed by our local bars, or as we see fit. The Florida meeting ended just before the invocation at the House of Delegates.

Steve Zachs from Miami is the current Chair of the House of Delegates. This is an extremely time consuming and demanding job. Imagine trying to control the debate among 550 lawyers, when at least a hundred of those lawyers have very passionate feelings on both sides of every issue before the House. Steve handles the job with a nice sense of humor while still managing to keep the train running on time. This year his job was made even more difficult than usual because of the Decennial report on Governance.

Every ten years the Governance Commission files a report on suggested changes for running the ABA. This year's report was the culmination of two years of public hearings, polling and group discussion. The report included numerous proposed changes to the ABA Constitution. The majority of the House meeting was dedicated to debate and voting on the proposed changes.

Matters up for change ranged from term limits for House members (failed), to restricting officers to be eligible for only one office (failed), to guaranteeing each section and division at least two delegates (passed) and allowing a law student as a non-voting member of the nominating committee (passed). A lot of this amounted to turf wars at its grittiest. The debates lasted until 6:00 p.m. Monday and resumed Tuesday morning at 8:00 am.

On Monday morning the House debate was suspended for an appearance by Attorney General Alberto Gonzales. Mr. Gonzales gave a speech outlining the Administration's priorities in the Justice system. Obviously, the confirmation of Judge Roberts to the Supreme Court was first on the list. He then mentioned a desire to see federal sentencing guidelines reworked to pass constitutional muster after the Booker decision. He stressed the dubious claim (in my mind) that federal sentencing guidelines are responsible for the current downward trend in crime and called on Congress to pass more mandatory minimum sentences as a way around the Supreme Court decision. His third priority was reenactment of the Patriot Act. He insisted that the FBI is not interested in what materials we are reading in the library, but the power to find out is necessary in the war on terrorism. I will refrain from further editorial comment. (It was interesting though to be seated next to former Attorney General William Reese Smith and to hear his comments on the current Attorney General's remarks. For a solo practitioner from West Palm Beach, it was pretty heady stuff.)

Monday morning also saw the ABA Medal awarded to Judge George Leighton. The son of immigrants, Judge Leighton was admitted to Howard University in 1936 on a provisional basis because he did not have a high school diploma. He graduated from Howard magna cum laude and received a scholarship to Harvard Law School in 1940. He left Harvard to fight in WWII and returned after the war to earn his law degree. He practiced law in Chicago and eventually became a federal district court judge. Judge Leighton is 93 years old, looks 63, and still teaches law school. He is a truly remarkable man.

On Tuesday morning the House was treated to a town forumtype meeting with Justice Stephen Breyer, Senator Lindsey Graham (R-S. Carolina), and former Solicitor General Theodore Olson. The discussion was moderated by Harvard Law School Professor Charles Ogletree. It was particularly interesting to watch Breyer and Graham interact. Both are very smooth, very polished, and very good at reading their audience. I'd like to be that good when I grow up.

Attending House of Delegates meetings can be very tedious. It can sometimes be very boring. But when its good, its very good. Thank you for allowing me to represent our Bar association. It is an interesting experience.

Personal Injury Corner



Pleading Punitive Damages

Two recent cases provide guidelines for what is necessary to plead punitive damages in Florida. In <u>Holmes</u> <u>v. Bridgestone/Firestone, Inc.</u>, 891 So. 2d 1188 (Fla. 4th DCA 2005), plaintiffs sued Firestone Tire Co. for an allegedly defective tire that caused a rollover. The complaint adding punitive damages was based upon a proffer regarding the tire company's knowledge of the defect which had been gleaned from the internet. The Court held that the standard of review in the appellate court was de novo and the test for determining the adequacy of the proffer to plead punitive damages was similar to the test for a motion to dismiss a complaint.

At Page 1191, the Court stated:

"When a trial court is determining if a plaintiff has made a "reasonable showing" under section 768.72 for a recovery of punitive damages, it is similar to determining whether a complaint states a cause of action, or the record supports a summary judgment, both of which are reviewed de novo. *W.R. Townsend Contracting, Inc. v. Jensen Civil Constr., Inc.*, 728 So. 2d 297 (Fla. 1st DCA 1999) (complaint); *Walsingham v. Dockery*, 671 So. 2d 166 (Fla. 1st DCA 1996) (summary judgment). In addition, where a trial court's ruling is based entirely on written evidence, the appellate court is in the same position as the trial court in weighing the evidence. *W. Shore Rest. Corp. v. Turk*, 101 So. 2d 123 (Fla. 1958). We therefore conclude that this a question of law." In Despain v. Avante Group, Inc., 900 So. 2d 637 (Fla.

In <u>Despain v. Avante Group, Inc.</u>, 900 So. 2d 637 (Fla. 5th DCA 2005) the Court was faced with a similar issue. Plaintiff's decedent was the resident of a nursing home and sought to amend her complaint to claim punitive damages. The trial court twice refused the proffer and the case went to trial resulting in a judgment for compensatory damages. On appeal, the Fifth District reviewed the standard necessary to plead punitive damages for a corporation and the standard of review of an appellate court in reviewing the trial court.

The landmark cases on punitive damages with respect to a corporate employer are <u>Schropp v. Crown Eurocars, Inc.</u>, 654 So. 2d 1158 (Fla. 1995) and <u>Mercury Motors Express, Inc. v.</u> <u>Smith</u>, 393 So. 2d 545 (Fla. 1981). <u>Schropp</u> holds that a corporation can be liable for punitive damages where there is willful and wanton misconduct on the part of a managing agent or primary owner on the basis of direct corporate liability.

A corporation can also be liable for punitive damages under <u>Mercury Motors</u>, <u>supra</u>, on the basis of vicarious responsibility. Liability for punitive damages under the vicarious theory under <u>Mercury Motors</u> requires an employee's conduct to rise to the level of willful and wanton misconduct and also requires some ordinary fault on the part of the corporation itself. Florida Statute 768.72 was amended in 1999 as part of the 1999 Tort Reform Act to include a new subsection which adopts a different standard for punitive damages. That standard became effective on October 1, 1999.

The 1999 amendment to § 768.72 does not appear to have changed the common law standard for determining who is a managing agent under <u>Schropp</u>, supra. In <u>Schropp</u>, the Court held that "If that person is managing agent or holds a policy-making position, liability for punitive damages is available." <u>See also Bankers Multiple Line Ins. Co. v. Farish</u>, 464 So. 2d 550, 533 (Fla. 1995) (imposing direct liability for punitive damages in a "managing agent or primary owner of the corporation"); <u>Kent Ins. Co. v. Schroeder</u>, 469 So. 2d 209, 210 (Fla. 5th DCA 1985) (imposing direct liability based on the actions of the "president and managing agent").

The 1999 amendment to Fla. Stat. 768.72(2) did change the level of conduct necessary on the part of a managing agent to hold the corporation liable for punitive damages. <u>Under Mercury Motors Express, Inc. v Smith, supra</u>, only ordinary negligence had to be shown. Under paragraph 2(b) of the above-quoted statute, the standard is now that "the officers, directors or managers of the ... corporation ... knowingly condoned, ratified or consented to such conduct" or (c) the corporation "engaged in conduct that constituted gross negligence and that contributed to the loss, damages, or injury suffered by the claimant."

Under Florida Statute 768.72(1) there must be a reasonable showing either by evidence in the record or by proffer which provides a "reasonable basis" for recovery of punitive damages. Record evidence can be supplied in the usual fashion by depositions, interrogatories and requests for admissions. A proffer, on the other hand, involves something that the plaintiff plans to prove rather than what is proved. The Court in <u>Despain</u>, supra, at Page 642 described a proffer as:

"a 'proffer' according to traditional notions of the term, connotes merely an 'offer' of evidence and neither the term standing alone nor the statute itself calls for an adjudication of the underlying veracity of that which is submitted, much less for countervailing evidentiary submissions.' Therefore, a proffer 'is merely a representation of what evidence the defendant proposes to present and is not actual evidence." (Citing cases.)

In <u>Despain</u>, the Court made it clear that an evidentiary hearing is not necessary in order to establish a proffer. Like the Fourth District, the Court in <u>Despain</u> concluded that since the trial court is not observing evidence, as it would in a trial, the standard of review in the appellate court is de novo rather than based upon an abuse of discretion. Also like <u>Holmes</u>, the Fifth District concluded in <u>Despain</u> that the standard to be applied both by the trial court and the appellate court is the same as that which applies with reference to whether a complaint states a cause of action. The Court explained that, just as in determining a motion to dismiss, the trial court must view the evidence with respect to a proffer in the light most favorable to the plaintiff. At Page 644 the Court holds:

"We are of the view that the standard that applies to determine whether a reasonable basis has been shown to *Continued on page 14*

Florida Bar Board of Governors Meeting Recap

At its August 26-27 meeting in St. Pete Beach, The Florida Bar Board of Governors:

- Approved a new legislative position in support of making DNA testing a permanent and meaningful component of Florida' criminal justice system, to help ensure that the real perpetrators of crimes are punished, the freedom of innocent people is protected, and the public's trust and confidence in the judicial process are not diminished.
- Heard President Alan Bookman and President-elect Hank Coxe report that they are working with the governor's office and legislature, emphasizing areas of common interest.
- Heard a report from the DPC that recommended that Bar rules not be amended to either: Specifically permit lawyers to enter into fee contracts with clients that mandate arbitration of malpractice; and give judges more guidance when considering petitions to exceed contingency fee limits set out in Bar rules.
- Debated a recommendation that \$25 of the \$250 fee to be paid by pro hac vice attorneys be set aside for the Clients' Security Fund. President Bookman said the issue is being referred to the Disciplinary Procedure and Budget committees.
- Tabled an advertising appeal which raised the question if a news story provided with information given to a prospective client at that person's request contained a prohibited testimonial, and if so, could it be banned. The board also heard a report from the Board Review Committee on Professional Ethics on an advertising appeal involving a law firm Web site. BRC Vice-Chair Larry Ringers noted the appeal involved the use of the words specializing and expert by attorneys who were not certified, which could arise again.
- Accepted the recommendation to refer to the City, County and Local Government Law Section a question involving Ethics Opinion 77-30, which had been raised by the Florida Ethics

Commission. That opinion says that a city attorney hired to represent an entire city commission cannot represent an individual commissioner before the Ethics Commission.

- Approved \$50,000 to match a similar amount from the Florida Bar Foundation to hire a statewide pro bono coordinator.
- Heard YLD President Jamie Moses report on a variety of issues, including that YLD leaders will be meeting with government lawyers to work on their concerns about the implementing of the new Practicing With Professionalism rules. Those rules ended the deferment that government lawyers get from attending PWP classes while they are on the public payroll.
- Had a retreat with section leaders on August 27 that discussed a wide variety of Bar-section issues, including the new revenue splitting plan and ways that the Bar and sections can help each other in their missions to educate members and improve the profession. Included in the retreat was an announcement that the Bar is working to upgrade the technology for its CLE offerings to include DVDs, CDs, and MP3s besides video and audiotapes.
- Participated, with section leaders, in a session with Supreme Court Justice Fred Lewis and Annette Boyd Pitts, executive director of the Florida Law Related Education Association, on conducting legal education programs for schools and other groups. The program emphasized teaching about basic constitutional rights, getting people to listen to each other, and how courts protect rights.

plead a claim for punitive damages should be similar to the standard that is applied to determine whether a complaint states a cause of action. *See Holmes* (holding that the analysis to determine whether a claimant has established a reasonable basis to plead a claim for punitive damages is similar to the analysis applied to determine whether the allegations of a complaint are sufficient to state a cause of action). Within the framework of this standard, we will view the record evidence and the proffer in the light most favorable to Despain and accept it as true. *Sobi v. Fairfield Resorts, Inc.*, 846 So. 2d 1204 (Fla. 5th DCA 2003).

These two cases make it clear that a proffer need not be based upon record evidence. The proffer must be viewed in the light most favorable to the plaintiff in determining whether there is any reasonable basis upon which punitive damages can be pled. 


