Judge John Parnofiello, the newest jurist appointed to the Palm Beach County bench exemplifies justice as envisioned by Plato. Watching his courtroom, there is no doubt that Judge Parnofiello is committed to the search for justice and communicating to all litigants in his courtroom the reasons for his rulings and the logic and law that underpins his analysis.

Raised in Boca Raton, John is a rare native to Palm Beach County. The son of an accountant and chief financial officer for a nationwide company and a homemaker, John always knew that he wanted to pursue justice on behalf of his fellow citizens. John saw his path of justice bringing him to the Federal Bureau of investigation, fighting for justice in the heart of our country.

John attended the University of Florida for both his bachelor's degree and his juris doctorate. From Gainesville, John returned to his hometown to begin his legal career as an Assistant State Attorney in Palm Beach County, where I had the pleasure of serving alongside him for almost eight (8) years. As a prosecutor, pursuing justice in the courtroom instead of the streets, John always exemplified professionalism, knowledge, confidence, and common sense. He has a thirst for legal knowledge that is both impressive and inspiring. John began his prosecutorial career prosecuting misdemeanor offense with the seasoned understanding of a far more experienced lawyer. He knew that successfully prosecuting these offenses required no only legal skills, but a sense of compassion and understanding for the human condition. But make no mistake, John was a tough prosecutor and a fierce advocate for the citizens on Palm Beach County.

Aside from a brief stint as an associate at Rosenthal Levy, John has spent his entire 15-year legal career as a prosecutor.
